III. PLACE AND DATE OF CONTRACT PERFORMANCE:

Poland, Świętokrzyskie Voivodeship – the city of Kielce; 3 June 2013.

IV. DESCRIPTION OF THE OBJECT OF THE CONTRACT:

- The contract is to develop and deliver an author's presentation and deliver lectures in the form of lectures and workshops on the practical application of the TRIZ-Technique/TRIZ-Management in business at a seminar promoting a project titled *TRIZ Academy for Business* on June 3, 2013. The seminar is organized to promote the project among the entrepreneurs from the Świętokrzyskie and the Małopolska regions and disseminate the knowledge about the capabilities and effectiveness of the application of the TRIZ method in solving organizational, technical and technological problems of enterprises.
- 2. The thematic scope of the lecture:

The seminar includes two separate lectures, which should reflect the purpose of the seminar and pertain to the topics mentioned below:

- 1/. Practical application of the TRIZ-Technique in business.
- 2/. Practical application of the TRIZ-Management in business.

Specific lecture topics will be proposed by the Speakers.

- 3. The responsibilities of each of the Speakers shall include:
 - 1/. Preparation and delivery in Polish, English and Russian of two one-hour author's lectures in the form of lectures and workshops during the organized seminar, regarding the scope of application of the TRIZ methodology in business (TRIZ-Technique the first Speaker, TRIZ-Management the second Speaker). Lectures should be practical and interactive (they should be illustrated with specific examples showing effective ways to use TRIZ methods for solving various kinds of "existence" problems in manufacturing and service companies, both in large well-known companies worldwide, as well as those used in small and medium-sized enterprises). Lectures should be prepared in view of the participants of the seminar, i.e. entrepreneurs and consultants participating in the TRIZ training on the I and II level of certification on MATRIZ scale. During the workshop, participants should be involved in solving a specific problem of a company (specific problems of

companies), get acquainted with a more appropriate methodology (rules) of conduct, in order to develop the most optimal solution for a given problem.

- 2/. Preparation and delivery in Polish, English and Russian of multimedia and / or audio-visual presentations for the given lectures, both in the form of a lecture and a workshop. Presentations should contain a minimum amount of text. They should be submitted electronically to the Ordering Party at least one week prior to the seminar.
- 3/. Active participation in the discussion, including responding to potential current questions about the use of the TRIZ methodology in business, asked by the participants of the seminar and the workshops.

V. CONDITIONS OF PARTICIPATION IN THE TENDER PROCEEDINGS:

- 1. The participation is open to individuals and legal entities.
- 2. Requirements for Speakers:
 - higher technical / managerial education,
 - expertise in the field of TRIZ methodology documented by certificates / attestations (possession of at least a third-degree TRIZ certification conferred by the *International TRIZ Association*), and, in addition, certified by a list of selected publications in this field, possibly with addresses of websites which contain these publications and information materials about the Speaker and / or its academic and professional achievements,
 - min. 5 years of professional experience gained by working in the enterprise/s and / or working for enterprises in different countries, regarding the use of TRIZ methods for the solution of specific organizational, technical or technological problems of these companies,
 - possession of the necessary skills and experience in public speaking, in particular, in performing talks related to the theme of the organized seminar,
 - min. 5 years of experience in the field of TRIZ training (TRIZ-Technique / TRIZ-Management).

 - photocopy of the MATRIZ certificate,
 - the completed form providing proof for the work experience of the Speaker, containing a list of examples of publications, conducted trainings, delivered lectures, in accordance with *Appendix 2* to this inquiry.
- 5. The Ordering Party does not allow submitting partial bids.
 - The Speaker should provide the gross price in zloty (PLN) for the execution of the service. The offered price should take into account the performance of all work and activities necessary for the proper performance of the order and take into account all the costs associated with its implementation and transfer of copyrights to the Ordering Party, performed on the conditions specified in the offer of the Contractor.

VIII. PLACE AND DATE FOR OFFER SUBMISSION:
