**Subject:** Responsibilities of the regional Managing Authorities to provide

comprehensive answers to the letter of formal notice of 14 July 2021

and to undertake corrective measures

Dear Marshals,

I would like to draw your attention to the fact that on 14 July 2021 the Commission started legal action against Poland for violations of fundamental rights of LGBTIQ people.

The Commission considers that the Polish authorities failed to fully and appropriately respond to its inquiry regarding the nature and impact of the so-called 'LGBTIQ-ideology free zones' declarations, statements or resolutions adopted by your regional authorities.

The letter of formal notice included multiple questions, which relate to the regional level of implementation of operations supported by the European Structural and Investment Funds (ESIF). Poland has two months to respond to the arguments put forward by the Commission. Otherwise, the Commission may decide to send a reasoned opinion and in a further step refer Poland to the Court of Justice of the European Union.

Consequently, I would like to underline your responsibility as managing authorities of EU funds to provide comprehensive answers to the questions raised by the Commission concerning the compatibility of the resolutions with applicable law, in particular with the principle of non-discrimination. At the same time I would encourage you to undertake any possible corrective measures with regard to the resolutions in order to eliminate the risk that fundamental values enshrined in Article 2 of the Treaty on EU (TEU)<sup>1</sup> as well as provisions of the Charter of Fundamental Rights are violated.

In accordance with Article 30(1) of the Regulation (EU) No 1303/20131<sup>2</sup> requests for any amendment of a programme shall always take into account the respect of horizontal principles set out in Articles 5, 7 and 8 of this Regulation. The actions of your regional authorities, which adopted declarations, statements or resolutions branding LGBTIQ community postulates as "an ideology" and declaring their territories LGBTIQ-unwelcome, put into question the capacity of regional managing authorities to ensure compliance with the horizontal principle of non-discrimination in the implementation of ESIF programmes. The Commission would like to stress that declaring LGBTIQ-free/unwelcome territories, workplace or services constitutes an action that is against the values set out in Article 2 of the Treaty on European Union. Therefore, we will put on hold the REACT-EU programme amendments in relation to your regional operational programmes.

Concluding, I underline that the Commission needs adequate and comprehensive clarification to the letter of formal notice and we would be grateful for your confirmation of any corrective actions taken in relation to the declarations.
